**Directions:** Take Highway 101 to the Gravenstein Highway (116 West) exit. Head west towards Sebastopol about 1/4 mile to Alder Avenue. Turn right on Alder and then turn right on the first street which is Ford Lane (Cotati Cottages sign). Proceed to the end of Ford Lane and park in the gravel parking spaces. Craig Collins and his wife, Sharon Eager, have run a very lovely gallery, West County Design, for some years now in Valley Ford, where they sell Craig's furniture and crafts by an array of artisans, potters, weavers, glass artists, etc. Jeff Barnell is a former chairman of SCWA, who until several years ago, had his own woodworking business in Santa Rosa. He now works with wineries in the area establishing their presence on social media, sites like Facebook, LinkedIn, Twitter and others. #### September Meeting Report

The guest speaker of the evening was Loy Davis Martin who entitled his presentation "Furniture Making: The Art of Interpretation."

Loy is an established custom furniture maker who is wellknown in woodworking circles. His pieces have appeared in many fine woodworking publications and he has written several articles that have appeared in many national journals. (Before taking up woodworking as an occupation, he was an English professor!) Loy knows SCWA well and has served as a judge for the Artistry in Wood show.

The bulk of Loy's presentation centered on many of the interesting pieces he has made over the years. Before getting into that, however, he discussed the process of getting from conception to finished piece. Loy's premise is that many influences feed into that process. He cited the writings of Garry Bennett and James Krenov (whom most people think were philosophically at odds) as supportive of this premise. Bennett wrote "Each piece is a reflection of the maker." Krenov wrote "The work is for yourself."

Loy feels that all of the above are truisms. He said that many elements come into play in determining the the final outcome of a piece, for example: Client desire, the skill of the builder, the influence of others, the client's lifestyle, materials and collaboration with other artists and craftspeople. He used the example of an analyst's bench he made for a San Francisco psychiatrist to demonstrate how these elements came into play in determining the final design and materials selection.

Loy then went on to describe many of his pieces including tables, chairs, display cases, casework, etc. The reader is referred to his website, www.loymartinfurniture.com, for pictures of the pieces he discussed at the meeting and many others.

Many of Loy's pieces make extensive use of highly figured woods, both domestics and exotics. Most of these woods he turns into 1/8" thick veneers, which he saws himself, enabling him to get the most of the fanciful grain patterns that are a feature of his furniture.

Loy said that his favorite finish is shellac and wax, but for surfaces exposed to alcohol and water he uses lacquer applied by a professional finisher that he has used for many years. He said that he is particularly fond of a water-based lacquer product called "Rubbed Effect" from Sherwin-Williams. He uses the lacquer sparingly in very fine films and then rubs it out to get the effect he wants. If he wants a very glossy finish he uses micromesh cloths up to 12,000 grit.

During the Q&A session following Loy's presentation, many of the questions focused on aspects of Loy's business. As we all know, not many woodworkers can make a good living out of commission work and the attendees wanted to know a bit about how he managed to be successful. Loy stated that, although he made some spec pieces and showed them in galleries, shows and magazines when he was starting out, all of his business now comes from word-of-mouth referrals. He charges a client \$750 - \$1000 for a "design fee" that includes drawings (and drawing revisions), wood samples and a fixed-fee proposal for the piece. Payment terms are normally 50% up front and the remainder on delivery of the finished piece.

Loy's clients are not confined to the Bay Area and come from all over the country, especially New York, Boston, Chicago, Arizona and Hawaii.

Although he resisted having a website for a long time, Loy now believes that having a web site is like having a business card. It is just part of the process of proving legitimacy. He found a website company called photobiz.com that specializes in making web sites for photographers that suits his needs perfectly. The service costs \$125 up front and\$15/month for hosting. He mentioned that the company provided terrific telephone tech

support and helped him get through all the design and implementation steps.

Loy does all of his design work on a computer using a CAD program called "Graphite" from a company named Ashlar-Vellum, http://www.ashlar.com/2d-3d-drafting/2d-3d-cad-graphite.html. Although the program supports 3D, Loy said he does all of his drawings in 2D. He uses a 30" monitor and has an HP 24" printer that produces copy large enough to produce paper drawings that he can transfer directly to stock

for making templates and jigs.

In conclusion, Loy stated that all of his pieces are one-of-a-kind, and that he has never made more than one of any piece (unless they are part of a set like dining chairs). He said that the only reason that he loses a sale today is because of price.


